

# **DP World App Privacy Policy**

### 1. Introduction and scope

This Privacy Policy describes Our policies and procedures on the collection, use and disclosure of your information when you use the application and tells you about your privacy rights.

We use Your Personal data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this Privacy Policy.

DP World is made up of different legal entities. When we mention "**DP World**", "**our**" or "**we**" in this notice, we are referring to the company in the DP World Group that is responsible for processing your personal information as your employer if you are an employee.

## 2. Collecting and Using Your Personal Data

#### **Personal Data**

While using **DP World App**, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you. Personally identifiable information may include, but is not limited to:

- Personal identifiers/details your name, role, which location you work from and department.
- Authentication information your Username and password.
- Contact information your business email address and business mobile and phone numbers.
- App adoption metrics confirmation that you have downloaded DP WORLD App.

## **Usage Data**

Usage Data is collected automatically when using the Service. When You access the App through a mobile device, we may collect certain information automatically, including, but not limited to, the type of mobile device You use, your mobile device unique ID, the IP address of Your mobile device, your mobile operating system, the type of mobile Internet browser You use, unique device identifiers and other diagnostic data.

## Information Collected while Using the Application

While using Our Application, to provide features of Our Application, we may collect, with Your prior permission:

Information regarding your location

We use this information to provide features of Our Service, to improve and customize Our Service. The information may be uploaded to the Company's servers and/or a Service Provider's server or it may be simply stored on Your device.

You can enable or disable access to this information at any time, through Your Device settings.

## 3. Use of your personal information

We use your personal information in DP WORLD App in line with our legitimate interests in managing our business, confirming your identity when you access DP WORLD App so we can keep it secure, monitor how many people have downloaded DP WORLD App, enabling DP World

colleagues to access business contact information, keep colleagues up to date with DP World news and announcements and give/receive feedback.

We may share Your personal information in the following situations:

- With Service Providers: We may share Your personal information with Service Providers to monitor and analyze the use of our Service, to contact You.
- With Affiliates: We may share Your information with Our affiliates, in which case we will require
  those affiliates to honor this Privacy Policy. Affiliates include Our parent company and any other
  subsidiaries, joint venture partners or other companies that We control or that are under
  common control with Us.
- With other users: when You share personal information or otherwise interact in the public areas with other users, such information may be viewed by all users and may be publicly distributed outside.
- **With Your consent:** We may disclose Your personal information for any other purpose with Your consent.

### 4. Data retention

We keep your personal information on **DP WORLD App** for as long as you remain an employee of DP World, after which your personal information will be no longer available on the app.

### 5. Disclosure of Your Personal Data

#### **Business Transactions**

If the Company is involved in a merger, acquisition or asset sale, Your Personal Data may be transferred. We will provide notice before Your Personal Data is transferred and becomes subject to a different Privacy Policy.

## Law enforcement

Under certain circumstances, the Company may be required to disclose Your Personal Data if required to do so by law or in response to valid requests by public authorities (e.g; a court or a government agency).

#### Other legal requirements

The Company may disclose Your Personal Data in the good faith belief that such action is necessary to:

- · Comply with a legal obligation
- Protect and defend the rights or property of the Company
- Prevent or investigate possible wrongdoing in connection with the Service
- Protect the personal safety of Users of the Service
- · Protect against legal liability

## 6. Your rights

In certain circumstances, you have the following rights under data protection laws in relation to your personal information:

- Right to access your personal information
- Right of data portability
- Right of rectification or erasure of your personal information
- Right to restriction of the use of your personal information
- · Right to object to the use of your personal information
- · Right to complain to us or your data protection regulator
